- 1. The Company Secretary welcomed all the members, Directors and other Panelists and started the meeting with the introduction of Directors and Panelists for the 33rd Annual General Meeting of the Company. After the introduction, Company Secretary requested Chairman to start the proceedings of the meeting.
- 2. The Chairman on behalf of Board of Directors again welcomed all the Members of the Company to the 33rd Annual General Meeting and opened the meeting as the requisite quorum was present.
- 3. The Chairman further informed that this AGM is being conducted through Video Conferencing / Other Audio Video Means, in short, VC / OAVM in accordance with the circulars issued by the Ministry of Corporate Affairs and by the Securities and Exchange Board of India (SEBI). The Chairman also informed that the company has tied up with Link Intime India Pvt. Ltd to provide facility for voting through remote evoting, e-voting during the AGM and participation in the AGM through VC / OAVM facility.
- 4. The Chairman informed the Members that in compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had provided to its Members, facility to cast their votes by electronic means through Remote E-voting in respect of all resolutions as set out in the Notice convening the 33rd Annual General Meeting. The Remote E-voting had commenced from 19th September, 2023 at 9.00 a.m. and ended on 21st September, 2023 at 5.00 p.m. The voting rights of the Members as on the cutoff date i.e 15th September, 2023, has been considered for ascertaining members entitled to cast their votes on resolutions set out in the Notice of this Annual General Meeting. The Chairman then informed the Members that those who have not voted through remote e-voting can cast their votes through e-voting facility during the AGM


